## ABOUT THE VENUE

The venue of the 51<sup>st</sup> R<sup>3</sup>Nordic Symposium in Cleanroom Technology & Contamination Control is Naantali Spa ([www.naantalispa.fi](http://www.naantalispa.fi)). Naantali is on the southwest coast 15 km north of Turku with distances to Helsinki 180 km, Tampere 160 km and Kuopio 460 km. You can e.g. take a ferry (Viking Line/Tallink Silja) from Stockholm or fly through Helsinki or Stockholm to Turku. The Old Town with its wooden houses and the presidential summer residence Kultaranta are attractive local sights.

## THE SCIENTIFIC & EXHIBITION PROGRAMME INCL. CALL FOR PAPERS

There will be 3 sessions on both Tuesday and Wednesday. The programme covers general aspects of cleanroom (R<sup>3</sup>) technology, R<sup>3</sup> news, R<sup>3</sup> applications and contamination control within the pharmaceutical, biotech and food industries as well as in hospitals and hospital pharmacies. The Pharma / Hospital Pharmacy & R<sup>3</sup> News / General -sessions run both days. Hospital and Food & Biotech are each 1-day long. All the presentations are given in English. There will be both invited lecturers and lecturers through submission of abstracts. To ensure latest scientific information in the programme we announce **Call for Papers**. Please, send your **topic suggestion with a short abstract** (each abstract 200-300 words) to [leila.kakko@tuni.fi](mailto:leila.kakko@tuni.fi) **at latest on 15<sup>th</sup> of September 2019**. Information on approval is available in mid-December 2019.

The **exhibition** is running both days. In the programme breaks, the participants can learn about the exhibitors' products / services.

## SOME WORDS ABOUT THE SOCIAL PROGRAMME

The social programme will start on Monday evening with a Get-together event (after the Annual Meeting). The Symposium banquet is on Tuesday evening. The lunches and coffee/tea during the breaks will be served in the exhibition area.

## CURRENT PARTICIPATION FEES INCL. OFFERS

In case you register by e-mail, we need all names at registration before we can register you and send out the invoice. The GO3PAY2 is only available for 2 days participation for industrial representatives. Participants from public institutes and hospitals will be entitled a **public fee** (Early Bird / Normal), which cannot be combined with the Go3Pay2-offer. The Early Bird fees are:
